The following team members are informed to act as members of Anti - Ragging committee from **21.07.2015 for the session 2025-26**. The committee members are informed to make surprise visits as per the schedule given below and one of the committee members are requested to write a brief report after Inspection in the register. These committees are formed to prevent and curb the menace of Ragging.

FUNCTION

On receipt of the recommendation of the Anti-ragging committee or on receipt of any information concerned to the incident of ragging, Head of the Institution shall immediately determine whether a case under the penal laws could be out and if so, either on his own or through an authorized member of the Anti-Ragging Committee, shall proceed to file a First Information Report (FIR), within 24 hours of receipt of such information or recommendation with the police and local authorities, under the appropriate penal provisions relating to one or more of the following.

RESPONSIBILITY

1. Abetment to ragging
2. Vigilant to criminal conspiracy to ragging
3. Observing and prevention of unlawful assembly and rioting while ragging
4. Public nuisance created during ragging
5. Violation of decency and morals through ragging
6. Injury to body, causing casual or grievous hurt
7. Wrongful restraint
8. Wrongful confinement
9. Use of criminal force
10. Assault as well as sexual offences or unnatural offences
11. Extortion
12. Criminal trespassing
13. Offences against property
14. Criminal intimidation
15. Attempts to commit any or all of the above-mentioned offences against the victim(s)
16. Threat to commit any or all of the above-mentioned offences against the victim(s).
17. Other offences following from the definition of "Ragging".
